Thank you for your request for a copy of your individual insurance passport.

The Australian insurance industry shares claim information between members of Insurance Reference Service Ltd (IRS), in order to make decisions about your insurance premium and the payment of your claims.

Veda collects claim detail on behalf of IRS, and this resource is the only collection of claim detail in Australia. The data can be used to verify the information that you disclose to insurers when you take out a policy, or when you submit a claim. .

It is important to correctly disclose all details requested by an insurer when applying for insurance or you may risk your claim being denied and you being held liable in full for any accident damage as a result.

Loss Assessor/Adjuster/Investigator enquiries:

These enquiries have been made by a third party on behalf of an IRS member insurer.

ALEXS DIRECT LOSS ASSESSOR advised that they made an enquiry on behalf of CLUB MARINE with reference to your Dealership policy. The date of loss is recorded as being 1/3/2001. The amount of this claim was \$34,234. This claim was due to EX, where you were the driver. The policy holder is DSFASDFA.

NICOLE'S 005 MEMBER advised that they made an enquiry on behalf of QBE with reference to your Travel policy. The date of loss is recorded as being 17/4/2000. The amount of this claim was \$10,000. This claim was due to TH, where you were the insured.

The information held within your insurance passport reflects those insurance events that have been submitted by members of IRS, and there has been sufficient detail utilised to be able to match the transaction detail to your identity file.
